The event was organized in Uppsala Sweden (7-8 November 2016), as part of the train the trainers activities of the project *Strengthening lawyers legal knowledge and cooperation with prosecutors and judges, to protect victims of human trafficking rights in the judicial proceedings,* financed by the European Commission, Justice Program JUST/2015/JTRA/AG/EJTR/8686. Its aim consisted in presenting to Romanian and Bulgarian legal experts' information on the Swedish antitrafficking and victims' protection strategies.

From Romania attended Silvia Berbec Lawyer and President of the NGO Association Pro Refugiu, Gabriela Bejan Lawyer; and from Bulgaria Genoveva Tisheva Lawyer and President of Bulgarian Gender Research Foundation, Vladimir Nikolov Prosecutor.

The topics were approached in an interactive manner and consisted in: the Nordic model to fight against human trafficking; the protective measures for victims of trafficking in Sweden; analyze cases of human trafficking and how Swedish legal professionals deal with them in accordance with the criminal legal procedures. The event was appreciated positively by the Romanian and Bulgarian participants who gained a detailed image on strategies & procedures, being able to transmit further the acquired data to other legal professionals in their countries.
